- 1. The SAR is undated.
- 2. Very minor portions of the SAR were redacted to prevent disclosure of personal information, such as social security numbers, and non-testimonial portions of the agent's work, such as her "theory" of the investigation or her recommendation as to which charges would be appropriate. The redaction on page 21 contains information about an unrelated grand jury investigation. I am sure you will agree that our production significantly exceeds our requirements under <u>Jencks</u>, and I assure you I have reviewed the limited redacted information to confirm it is not subject to disclosure.
- 3. To the best of my knowledge, the SAR I provided is the SAR that the Tax Division received.
- 4. Exhibit 1 is not subject to disclosure. Nevertheless, in my continued efforts to work with you in good faith, it is attached.

It is, therefore, requested the Criminal Investigation evaluate the information developed to this point to see if they agree their involvement in a grand jury investigation is warranted.
